

TERMS AND CONDITIONS

1. Interested parties may submit their highest prices for the said vehicle in sealed cover latest by **1130 HRS** on or before **06/01/2023** and on the same day at **1530 Hrs.** It will be opened before the bidders or their representatives, if any. The inner cover containing quotations and other relevant documents along with DD/Pay Order/Banker's Cheque towards EMD should be sealed properly. The cover should be put in another outer cover and may be dropped in the Tender Box kept at second floor of the Directorate of Tourism, A&N Admn, Port Blair. Both the inner and the out covers should be super scribed in Bold Capital letters '**TENDER CUM AUCTION FOR DISPOSAL OF 01 NO CONDEMNED VEHICLE MARUTI GYPSY-AN-01-A-8299**'.
2. The disposal of vehicle shall strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this department. The condition of the vehicle can be inspected physically from **19/12/2022 to 06/01/2023** at Andaman Teal House, Port Blair between working days from **1000 Hrs to 1600 Hrs.** In this regard Assistant Director (Admn.), Vehicle In-Charge, Directorate of Tourism, A&N Admn may be contacted. No complaint whatsoever will be entertained after the tender submitted or before the vehicle are lifted. No request for inspection after submission of tender will be accepted.
3. The sealed quotation should be accompanied by Earned Money Deposit for **₹2,000/-** (Rupees Two Thousand Only) in the shape of Pay Order/Demand Draft/Banker's Cheque for **₹ 2000/-** (Rupees Two Thousand only) in favour of The Senior Accounts Officer, Directorate of IP&T, Andaman & Nicobar Administration as refundable security (EMD). If the highest tenderers/successful tenderer accepted by the competent authority in this Department fails to deposit the sale price within the prescribed time limit, his EMD will be forfeited. In case the offer is withdrawn by any tenderer, the EMD deposited by him shall be forfeited.
4. EMD amount is payable by means of DD/pay order/banker's Cheque in favour of Senior Account Officer, Directorate of IP&T, A&N Admn. offers received without EMD amount shall not be considered at all by this Department.

5. The Successful bidder will be required to deposit the total bid amount to the Cashier, Directorate of IP&T, A&N Admn within seven working days of award of contract.
6. EMD of the successful bidder will be released only after realization of the Sale proceed amount. Earned Money Deposit of the bidder who fails to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Department. EMD of the successful bidder shall be released only after successful completion of the sale process.
7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voter Identity Card) in case of individual and Registration Certificate in case of firms etc.
8. The sold vehicle should be removed by the successful bidder within 48 hours of depositing money at his own expense. No assistance/transportation will be provided by the department. Permission to take out the deposited vehicle from the Andaman teal house premises will not be allowed on holidays ,and Sundays etc.
9. The successful bidder will also be responsible for getting the Registration Certificate of the Vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
10. The Director (Tourism) A&N Admn reserve the right to reject all or any tender/quotation in whole or part without assigning any reason thereof.
11. The bidder is to reveal his full name/name of the authorised signatory of the firm/name of the father, full postal address, telephone number and mobile number.
12. Disputes, if any, shall be subject to jurisdiction in the Court of Port Blair only.
13. If the highest quoting firm fails to honour the bid, the contract will be cancelled and its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1 party. In case of any dispute , decision of the Director (Tourism), A&N Admn shall be final.
14. Tendering form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations not signed by authorized signatory shall be rejected.
15. Tendering firm/individual shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.


