NOTICE INVITING PROPOSAL

The Tourism Department, A&N Administration invites tenders from experienced Consultants/Consortium of Consultant for “ Preparation of Detailed Project Report (DPR) and Request for Proposal (RFP) for selection of private partners for development of 11 eco-tourism sites in Andaman & Nicobar Islands on PPP mode.

2. Eligibility Criteria :

- 2.1 Reputed firms having experience of providing consultancy services for Project development to Central and State Governments, Ministries and Departments or their affiliated agencies for at least three years. The experience required for startups will be at least one year.

The firm should have satisfactorily prepared Detailed Project Reports or provided Project development services to a Government agency/department for at least one eco tourism site with minimum consultancy cost of Rs. 50 lakhs within the last three financial years. For startups, the requirement would be at least one eco tourism site with minimum consultancy cost of Rs. 20 lakhs within the last one year. Proof of such assignments and completion certificate should be enclosed.

- 2.2 The average annual turnover of the bidder for each of the last three Financial Years (including that ended March 2020) shall not be less than Rs. 50 lakhs from Consultancy services for Project development. The annual turnover requirement for start ups will be Rs. 20 lakhs in the last financial year.

- 2.3 Firm should not have been blacklisted and suspended from empanelment/participation in any tender from any of the government agencies.

The Consultant will be selected on Quality-cum-cost Based Selection (QCBS) .

3. **Earnest Money Deposit:** The EMD in the form of FDR/DD/Bank guarantee/deposits at call of any Nationalized Bank in favour of Secretary-cum-Director(Tourism) payable at Port Blair should be submitted by the tenderers except Micro and Small Enterprises (MSEs) as defined in MSE Procurement policy issued by Department of Micro, Small and Medium Enterprises(MSME). Such tenderers have to upload the MSME certificate in place of EMD.

A scanned copy of the EMD has to be uploaded online and the original EMD has to be sent by post . EMD should remain valid for a period of forty five days beyond the final bid validity period.

4. The Tenders have to be submitted online. The technical proposal of only those tenderers will be evaluated who qualify in the prequalification proposal. The financial proposals of only those tenderers will be opened who will score the minimum qualifying marks as per QCBS procedure in the technical proposal. Financial proposals/ bids of tenderers who do not qualify shall not be opened .

4.1 The first stage shall contain the pre-qualification documents as per format given in section 4. It should essentially include EMD of Rs.200,000/- as well as Certificate for not being blacklisted//disqualified (as per para 2.3)

4.2 The second stage shall contain the technical proposal including the following:
Proof of similar works executed (as per para 2.1)
Details of Engineers/Architect/Professionals (as per Para 2.2)

4.3 The third stage shall contain only financial proposal/ bid.
