It has been decided to suspend all tourism activities in the National Memorial Cellular Jail, Netaji Subhash Chandra Bose Island, also including the Light & Sound Show at both these places, all museums, all beaches, Baratang Caves, all Water Sports activities, and any other such tourism activities in all the three Districts, for 04 weeks starting from 22/04/2021.
